### **Experience:**

I have been in the construction industry for over 29 years and a licensed General Contractor for over 8 years. I was my father's caregiver for 17 years after my mother passed; which gives me another viewpoint in this specialized area.

I earned my NAHB Certified Aging-in-Place Specialist (CAPS) in 2008, and became an approved instructor in 2011 and an instructor for the Universal Design/Build course in 2015. I have taught the CAPS course for about 5 years at the BIA of Hawaii. I made the decision to become an NAHB instructor because I wanted to share the information that only attending the CAPS courses gives you. The course is not strictly for contractors, but this educational course is beneficial to various allied professionals, such as architect, interior designers, physicians, nurses, occupational and physical therapist, medical equipment specialist, realtors, the public etc...

The number one reason industry professionals join and continue to be members of an HBA, is education opportunities; which is another pathway to increasing membership. As a CAPS instructor, my goal is to have the students have a real-world experience, rather than just hearing information from the student guide. I want them to understand why pathways are a certain width, why the degree of a slope is important to everyone that uses it, why floor transition must be a certain height etc....all this information sounds reasonable in class; but to physically experience it makes a larger impact to their comprehension and





reasoning. This informational awareness as a certified aging-in-place specialist will benefit them, their company, clients, family, friends etc...

My goal is to educate realtors, contractors, architects; designers, OT/PTs and other allied professionals, so they increase their knowledge and understanding of AIP, UD and IL, which would be beneficial to their clients, family and friend's activities of daily living.
